NOTIFICATION AND CONSENT

Pursuant to Sections 6 and 7, respectively, of the Personal Data Protection Act 2010

1. Collection and processing of Personal Data

We, Euangelion Training and Services Sdn. Bhd. (also known as Equip Gospel Minsitries), its employees and officials (collectively, "Equip" or "we") have or will collect, record, hold, store, use, disclose and/or process (collectively referred to as "Process") one, or all of the following categories and/or types of personal information about you and any other persons, including but not limited to the following:

- a) master data: name, gender, date of birth, church attended.
- b) contact details: home address and billing address, home phone number and mobile number, email address; and

4. Storage and Security

5. Disclosure

Your Personal Data provided to us will, generally, be kept confidential but you hereby consent and authorise us to provide and/ or disclose your Personal Data to the following categories of parties:
